

TERMS AND CONDITIONS: "SPOT THE SAFETY FLAWS" CONTEST

1. General

These Terms and Conditions apply to the "Spot the Flaws" contest (the "Contest") organized by Qlicksmart Pty Ltd (the "Organizer"). By participating in the Contest, entrants agree to be bound by these Terms and Conditions.

2. Eligibility

This Contest is open to individuals who are eighteen (18) years of age or older at the time of entry who are legal residents of the country in which it is being held. By entering the Contest as described in these Contest Rules, entrants represent and warrant that they are complying with these Contest Rules (including, without limitation, all eligibility requirements), and that they agree to abide by and be bound by all the rules and terms and conditions stated herein and all decisions of Sponsor, which shall be final and binding.

3. Entry

3.1. By entering the Contest, the entrant accepts these terms and conditions. A person may only enter the Contest once and must enter the Contest during the Contest Period. In order for the Organizer to notify the winners, the entrant must provide their full name and e-mail address. The Organizer may deem an incomplete entry invalid if this information is not provided.

3.2. No purchase is necessary to enter or win. To enter, participants must:

- Access the official Contest page at <https://www.qlicksmart.com/fix-this/> Examine the provided photograph(s).
- Identify the faults/errors depicted in the image.
- Complete the online submission form detailing the faults found and providing valid contact information. Limit of one (1) entry per person.

4. Prizes

4.1. The Individual Prize: The individual winner will receive one (1) Gift Pack containing five (5) Qlicksmart SnapIT Lite Ampoule Openers and a Qlicksmart pen.

4.2. The Facility Prize: The facility which has the most number of entries ("The Facility") will receive between 1 month to 3 months supply of sterile scalpel blade removers (Qlicksmart BladeCASSETTE or BladeNeedleSYSTEM).

4.2.1. Quantity Calculation: The volume will be calculated based on (1) the facility's average historical usage or (2) a fixed maximum quantity of units. The quantity calculation will be solely decided by the Organizer.

4.2.2. Fulfillment: The Facility Prize will be physically provided by the authorized Distributor located in the winner's country/region.

4.2.3. The Facility cannot exchange this prize for cash or credit.

5. Selection

5.1. The winner of the prize will be chosen by the Organizer. This is a game of skill and the winner will be chosen by the Organizer based on the results of the Spot the Flaws Competition.

5.2. The entries will be judged based on accuracy and completeness.

5.3. The winner will be the entrant who correctly identifies the highest number of faults in the photograph.

5.4. Tie-Breaker: In the event of a tie where multiple entrants identify the same number of faults, the winner will be determined by: a random draw among the top scorers OR the entrant who submitted their entry earliest based on the server timestamp.

5.5. The Organizer's decision is final and binding in all matters relating to this Contest.

6. Winner

6.1. The winner of the prizes will be announced within 7 business days after the competition finishes. The winner will be the contestant will be the entrant who correctly identifies the highest number of faults in the photograph within the given time period and rules.

6.2. The winner of the prize must sign any release form that may be required by the Organizer or supplier of a prize.

6.3. After announcement of the winner, the Organizer will present the prize to said winner.

6.4. The winner will be notified via email or phone call (if those details are given) within 14 days of the Contest End Date.

6.5. The winner must respond to the notification within 14 days to claim the prize. If the winner fails to respond, the Organizer reserves the right to select the next highest-scoring entrant.

6.6. Verification of employment at the stated Facility may be required before the Facility Prize is awarded.

7. Unclaimed Prizes

7.1 If a prize is unclaimed, the Organizer will announce the second place contestant as a winner for the unclaimed prize 21 days after the initial contest and will notify the winner via phone call or email if details are given. The selection will take place at the Organizer's office.

7.2 The Organizer may forfeit a prize if a winner refuses to accept a prize.

8. Entrant's personal information

By entering this Contest and with permission from the entrant, the entrant consents to:

- a. the Organizer, or any of its affiliated entities, using the entrant's details for future marketing and promotional purposes, except if notified otherwise by the entrant;
- b. if entrants are winners, the Organizer using their name, likeness, image and/or voice in any media platform; and
- c. disclosing the entrant's personal information to the local distributor of the Organizer's products and services.

9. Organizer's Rights

The Organizer may verify the validity of entrants (including an entrant's identity, age and place of residence). The Organizer may disqualify an entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The Organizer may either disqualify an entrant or modify, suspend, terminate or cancel the Contest if the Contest is interfered with or the Contest is not capable of being conducted as reasonably expected due to a reason beyond the control of the Organizer, including technical difficulties, natural disasters, terrorist threats, unauthorised intervention, or fraud.

10. Organizer's Liability

The Organizer is not liable for any discomfort, loss, expense, damage or liability that may be suffered or incurred by a person in entering the Contest or accepting and using the prizes. If the Organizer is liable, the Organizer's liability is limited to either resupply of the goods or services.

11. Privacy

11.1. Personal data collected during the Contest will be used for the purpose of administering the Contest and prize fulfillment.

11.2. By entering, the winner agrees to the use of their name and facility name for promotional purposes without additional compensation, unless prohibited by law.

12. Governing Law

These Terms and Conditions are governed by the laws of the country and/or state from where it is being held.
